
In exercise of the power conferred under Section 35 of the insolvency & Bankruptcy Code, 2016 ("Code") to the Liquidator of the Enestee Engineering Limited ("the Company"), hereby publicly notify that in furtherance of the order dated 16.09.2020 passed by the National Company Law Tribunal, Bench at Mumbai in Company Petition (IB) 1385/2019 (whereby the process of liquidation of the company was commenced, the assets of the company have been sold through slump sale under regulation 32 (b) of the Insolvency and Bankruptcy Board of India (Liquidation Process) Regulations, 2016 on "As is where is basis", "As is what is basis", "Whatever there is basis " and "No recourse" basis'. The sale has been concluded in favor of Sunny Infraengineers Private Limited ("Successful Auction Purchaser) on 18.08.2021 and the possession of the assets sold have been handed over to Successful Auction Purchaser on 18.08.2021.

There are no other substantial assets in the Company. Hence, after complying with the requisite procedure under the Code, the Company is likely to proceed with dissolution under section 54 of the Code in accordance with law.

As there are no other assets of the Company, the Liquidator is hereby terminating the services of the workmen and employees named in Annexure "A" to the notice with immediate effect that is from 20.08.2021, the date of publication of this notice. Please be assured that the said decision does not reflect on your capabilities as the same has been taken only for the reasons as mentioned hereinabove.

The amount legally due shall be paid as per applicable laws including Insolvency and Bankruptcy Code, 2016
